There are two requests for allowable growth on this month's agenda. After the student reporting is done each fall, a district has the opportunity to request allowable growth in three different areas of which the Harlan Community School District has the opportunity to request two this year. The first request for allowable growth is for Open Enrollment Out Students on Fall 2020 Certified Enrollment that were not on the Fall 2019 Certified Enrollment. A district can only qualify for this if they have decreasing enrollment. This request is for \$41,280.00 and the funds are received as part of our general fund property taxes. The second allowable growth request is for Educating ELL Students Beyond 5 Years. This allows us to recoup the costs of educating ELL students if their ELL instruction requires more than 5 years. This request is for \$9,329.76. We have 6 students that we are educating beyond 5 years and we receive a 0.22 for each for a total weighting of 1.32 and this is taken times the current year district cost per pupil (7,068.00) to come up with the \$9,329.76 request. The funds are received as part of the ELL property taxes. Both of these requests allow the district to receive the authority for costs beyond what would be deemed normal.
